BOI Board Approves 14 Projects

Automotive Parts manufacturers Lead Investments in Advanced Automotive Cluster

Mrs. Hirunya Suchinai, Secretary General of the Thailand Board of Investment (BOI), revealed after the BOI board meeting chaired by Prime Minister General Prayuth Chan-o-cha that the board had approved of 14 projects, a total investment value of 39,329.44 million baht.

Activities in agriculture and agricultural products sector, including:

- 1. Pet Focus Company Limited: Expansion of pet food manufacturing in Lopburi (production capacity of 86,400 tons per year) with a total investment value of 1,338.1 million baht.
- 2. Green Spot Company Limited: Expansion of grain beverages manufacturing in Saraburi (production capacity of 162,000,000 litres per year) with a total investment value of 4,680.9 million baht.
- 3. Sunshine Biotech International Company Limited: Expansion of sweetener such as maltose syrup and glucose manufacturing in Prajinburi (production capacity of 3,600 tons per year) with a total investment value of 1,734.3 million baht.
- 4. Kampangpetch Bio Ethanol Company Limited: Ethanol 99.5% manufacturing in Kampangpetch (production capacity of 60,000,000 litres per year) with a total investment value of 1,500 million baht.

Activities in mineral, ceramics and basic metals sector, including:

5. Kabinburi Glass Industry Company Limited: Expansion of float glass manufacturing (production capacity of 198,000 tons per year), tempered glass

manufacturing (production capacity of 198,000 tons per year), and glass bottle manufacturing (production capacity of 105,600 tons per year) in Prajinburi with a total investment value of 7,645 million baht.

Activities in metal products, machinery and transport equipment sector, including:

- 6. Siam Kubota Corporation Company Limited: Expansion of agricultural machinery equipment and parts such as rotary cultivator manufacturing in Chonburi (production capacity of 72,000 sets per year) with a total investment value of 2,030.6 million baht.
- 7. Bangkok Can Manufacturing Company Limited: Expansion of aluminum can manufacturing in Ayutthaya (production capacity of 800,000,000 pieces per year) with a total investment value of 2,660 million baht.

Investments under the Super Cluster policy:

8. Mr. Cartern Zur Steege and Mr. Wataru Hamaura: Vehicle parts such as an electronic fuel injector manufacturing in Rayong with a total investment value of 1,754.1 million baht. This is the first large scale investment being granted incentives under the special economic zone cluster-based policy.

Activities in electronics and electrical appliances sector, including:

9. Insee Digital Company Limited: Software production in Bangkok with a total investment value of 2,159 million baht.

Activities in chemicals, paper and plastics sector, including:

- 10. Advance Pulp Mill 3 Company Limited: Bleached pulp manufacturing in Buriram (production capacity of 472,500 tons per year) with a total investment value of 6,460 million baht.
- 11. Prepack Thailand Company Limited: Expansion of printed matter such as flexible packaging manufacturing in Samut Songkram, Samut Sakorn, and Rayong (production capacity of 7,000 tons per year) with a total investment value of 1,197 million baht.

Activities in services and public utilities sector, including:

- 12. TTW Public Company Limited: Expansion of water supply production in Samut Sakorn (production capacity of 36,500,000 cubic meter per year) with a total investment value of 2,147.44 million baht.
- 13.ST Power Group Company Limited: Expansion of industrial estate 1,941 rai consisting of the area for industrial estate 1,280 rai and the area for public utilities and public area 660 rai, located at Chonburi with a total investment value of 2,523 million baht.
- 14. Thai Polyethylene Company Limited: Research and development of the catalyst's formula and process such as the catalyst of polypropylene located in Rayong with a total investment value of 1,500 million baht.
