BOI Board approves another Bt40 billion in investment projects

Thailand's Board of Investment approved 15 more projects worth over 40,000 million baht, bringing the total number of projects approved over the past two months to 121, worth a total of 318,839.5 million baht.

Mr. Udom Wongviwatchai, Secretary General of Thailand Board of Investment (BOI), said that the new Board of Investment has already convened three times. In the first two meetings, the board had already approved 106 projects totaling 278,301.5 million baht.

Most of the large-scale projects latest approved are steam power production, ethanol production and automotive parts production.

List of projects approved at the recent BOI Board meeting:

- 1. P.S. Food Products Co., Ltd., to expand the production of slaughtering activity in Samutprakarn (capacity of approximately 106,920 tons per year) with a total investment value of 1,736 million baht.
- 2. Monde Nissin (Thailand) Co., Ltd., to produce ready-to-eat foods in Chonburi (capacity of approximately 24,840 tons per year) with a total investment value of 1,030.5 million baht.
- 3. Sapthip Co., Ltd., to product 99.5% ethanol from cassava in Lopburi (capacity of approximately 99,000,000 liters per year) with a total investment value of 1,588 million baht.
- 4. Mr. Tubchai Phanitpichetwong, to produce 99.5% ethanol from molasses in Kamphaeng Phet (capacity of approximately 60,000,000 liters per year) with a total investment value of 1,300 million baht.

- 5. Ratchasima Green Energy Co., Ltd., to produce 99.5% ethanol from cassava in Nakorn Ratchasima (capacity of approximately 108,900,000 liters per year) with a total investment value of 2,046.8 million baht.
- 6. Isuzu Engine Manufacturing (Thailand) Co., Ltd., to expand the manufacture of diesel engines in Bangkok (capacity of approximately 185,000 pieces per year) with a total investment value of 5,132.9 million baht.
- 7. Gulf NLL2 Co., Ltd., to generate electricity or steam in Rayong (electricity capacity of approximately 133 megawatts, and steam capacity of approximately 30 tons per hour) with a total investment value of 5,172 million baht.
- 8. Gulf BL Co., Ltd., to generate electricity or steam in Pranakorn Sri Ayutthaya (electricity capacity of approximately 133 megawatts, and steam capacity of approximately 30 tons per hour) with a total investment value of 5,082 million baht.
- 9. Gulf BP Co., Ltd., to generate electricity or steam in Pranakorn Sri Ayutthaya (electricity capacity of approximately 133 megawatts, and steam capacity of approximately 30 tons per hour) with a total investment value of 5,159 million baht.
- 10. Gulf NPM Co., Ltd., to generate electricity or steam in Saraburi (electricity capacity of approximately 133 megawatts, and steam capacity of approximately 30 tons per hour) with a total investment value of 5,148 million baht.
- 11. BuaYai Bio Power Co., Ltd., to generate electricity from biomass such as bark and chopped wood in Nakorn Ratchasima (capacity of approximately 55 megawatts) with a total investment value of 1,920 million baht.
- 12. Nongkhai Nar Yu Co., Ltd., to generate electricity from garbage in Nongkhai (capacity of approximately 4.9 megawatts) with a total investment value of 968.7 million baht.
- 13. K Motor Sport Co., Ltd., to operate a 4,554-meter car racetrack and equipment for rental in Buriram with a total investment value of 2,500 million baht.
- 14. Precious Opal Co., Ltd., to expand its sea shipping operation with a total investment value of 876.80 million baht.
- 15. Precious Rubies Co., Ltd., to expand its sea shipping operation with a total investment value of 876.80 million baht.

In addition, the BOI Board has approved another 2 companies for project amendment, which are

1. Toyotomi Auto Parts (Thailand) Co., Ltd., to additional manufacture molds vehicle parts in Chachoengsao (capacity of approximately 100 pieces per year) with a total investment value of 250 million baht.

2. Denso (Thailand) Co., Ltd., to expand the manufacture of vehicle parts (capacity of
approximately 1,800,000 pieces per year) and radiators (capacity of approximately 42,490,000
pieces per year) in Chachoengsao with a total investment value of 168 million baht.
