BOI approves 18 investment projects worth nearly Bt90 billion

The Board of Investment has approved 18 large projects and 2 amendment projects worth 8.9 billion baht. Out of these, five are Eco-car Phase 2 Projects and nine are alternative energy power plants such as biomass, general waste, natural gas and wind power. The investment value of all the projects approved already exceeds 450 billion baht.

Mr. Udom Wongviwatchai, the BOI Secretary General, revealed after the BOI board meeting chaired by General Prayuth Chan-ocha, Prime Minister and chief of the National Council for Peace and Order (NCPO), that the board had approved 18 projects and 2 amendment projects, with total investment value of 89,713.4 million baht. Since the NCPO appointed the BOI board on 8 June 2014, the board has approved investment incentives for 603 projects worth 458,595 million baht.

The projects approved by the BOI Board in the latest board meeting include:

- 1. Ter Long (Thailand) Company Limited: hot rolled steel manufacturing in Rayong (approximate capacity of 600,000 tons) with a total investment value of 1,440.5 million baht
- 2. Mr. CHANG, HSIEN-MING: iron casting and industrial machinery parts manufacturing in Chonburi (approximate capacity of 80,000 tons and 4,000 tons respectively) with a total investment value of 2,450 million baht
- 3. Thai Asahi Kasei Spandex Company Limited: spandex bare yarn production in Chonburi (approximate capacity of 3,700 tons) with a total investment value of 1,200 million baht

- 4. MMth Engine Company Limited (MEC): plastic auto parts manufacturing in Chonburi (production capacity of 1,191,670 units per year) with a the total investment value of 1,089.4 million baht
- 5. Ford Motor Company (Thailand) Company Limited: car manufacturing under the Ecocar Phase 2 Project in Rayong (car production capacity of 180,000 units and 2,000 engines per year) with a total investment value of 18,180 million baht
- 6. General Motors (Thailand) Company Limited: car manufacturing under the Eco-car Phase 2 Project in Rayong (production capacity of 158,000 units per year) with a total investment value of 13,109 million baht
- 7. Nissan Motor (Thailand) Company Limited: car manufacturing under the Eco-car Phase 2 Project and auto parts in Samut Prakarn (car production capacity of 123,000 units and auto parts production capacity of 2,000,000 units per year) with a total investment value of 6,860 million baht
- 8. Mitsubishi Motors (Thailand) Company Limited: car manufacturing under the Eco-car Phase 2 Project in Chonburi (production capacity of 233,000 units per year) with a total investment value of 4,900 million baht
- 9. TOCGC Company Limited: purified ethylene oxide project in Rayong (production capacity of 60,000 tons per year) with a the total investment value of 2,826 million baht
- 10. Korat Wind Energy Company Limited: electricity generation from wind power project in Nakhon Ratchasima (production capacity of 52.5 megawatts) with a total investment value of 3,690 million baht
- 11. RES Nakhon Ratchasima Company Limited: electricity generation from general waste in Nakon Ratchasima (production capacity of 9.98 megawatts) with a total investment value of 970 million baht
- 12. TPI Polene Public Company Limited: electricity generation from refuse derived fuel in Saraburi (production capacity of 70 megawatts) with a total investment value of 3,165.7 million baht
- 13. Rajburi Sugar Company Limited: electricity generation from biomass in Ratchaburi (production capacity of 44 megawatts and steam generator production capacity of 300 tons per hour) with a total investment value of 1,306.6 million baht

- 14. Uthaithani Bio Energy Company Limited: electricity generation from biomass in Uthai Thani (production capacity of 35 megawatts) with a total investment value of 1,050 million baht
- 15. CHP-1 Company Limited: electricity generation from natural gas and steam in Prachinburi (natural gas production capacity of 125.8 megawatts and steam generator production capacity of 16 tons per hour) with a total investment value of 4,983 million baht
- 16. Sahacogen (Chonburi) Company Limited: electricity generation from natural gas and steam in Chonburi (natural gas production capacity of 42 megawatts and steam generator production capacity of 30 tons per hour) with a total investment value of 1,350 million baht
- 17. KR ONE Company Limited: electricity generation from wind power project in Nakhon Ratchasima (production capacity of 100 megawatts) with a total investment value of 6,203.2 million baht
- 18. Bangpa-in Cogeneration Company Limited: electricity generation from natural gas and steam in Phra Nakhon Si Ayutthaya (natural gas production capacity of 117.5 megawatts and steam generator production capacity of 20 tons per hour) with a total investment value of 5,340 million baht

There are 2 amendment projects with additional investment, which are

- 19. Mitsubishi Motors (Thailand) Company Limited: car manufacturing under the Eco-car Phase 1 and 2 Projects in Chonburi with a total investment value of 7,700 million baht and an increase in production capacity from 180,000 units to 220,000 units in order to support the international market demand
- 20. Toyota Motor (Thailand) Company Limited: car manufacturing under the Eco-car Phase 2 Project, with an additional 1,900 million baht in investment value and an increase in production capacity from 100,000 to 160,000 units per year in order to support the domestic and international market demand
