BOI approves 23 investment projects worth nearly Bt 80 billion baht

Green light to 4 Eco-car Phase 2 projects

The Board of Investment has approved 23 projects worth more than 81,735 million baht in investment value. A green light has been given to four Eco-car Phase 2 projects worth 34,000 million baht, as well as two power plants generated from refuse and agriculture waste. Nok Air, a Thai aviation business, aims to increase its air transportation capability with increased investment.

Mrs. Hirunya Suchinai, Acting Secretary General of the Thailand Board of Investment (BOI), revealed after the BOI board meeting chaired by Prime Minister General Prayuth Chanocha that the board had approved **23 projects, with total investment value of 81,735 million baht,** including:

- 1. Mr. Adisak Pramuanmitra: rice bran oil and animal feed ingredients manufacturing in Phra Nakhon Sri Ayutthaya (approximate capacity of 68,310 tons) with a total investment value of 2,222.7 million baht
- 2. Bangchak Biofuel Public Company Limited: bio diesel fuel manufacturing in Phra Nakhon Sri Ayutthaya (approximate capacity of 172,000,000 liters) with a total investment value of 975 million baht
- 3. Kaihara (Thailand) Company Limited: fabric manufacturing in Ratchaburi (approximate capacity of 14,400,000 meters per year) with a the total investment value of 3,144 million baht

- 4. Sparktech (Thailand) Company Limited: metal shell manufacturing and metal plating in Chonburi (approximate capacity of 86,184,000 units and 21,816,000 units per year, respectively) with a total investment value of 2,266 million baht
- 5. Aisin AI (Thailand) Company Limited: car transmission manufacturing in Chachoengsao (approximate capacity of 219,040 units per year) with a total investment value of 2,250 million baht
- 6. TS TECH (Kabinburi) Company Limited: auto parts manufacturing in Prachinburi (approximate seat frame part production capacity of 220,000 units, automotive seats production capacity of 240,000 units and automotive door panels production capacity of 240,000 units per year) with a total investment value of 1,320 million baht
- 7. Toyota Motor Thailand Company Limited: car manufacturing under the Eco-car Phase 2 Project in Chachoengsao (approximate capacity of 100,000 units per year) with a total investment value of 10,406 million baht
- 8. SAIC Motor CP Company Limited: car manufacturing under the Eco-car Phase 2 Project in Rayong (approximate capacity of 110,000 units per year) with a total investment value of 7,610 million baht
- 9. Suzuki Motor (Thailand) Company Limited: car manufacturing under the Eco-car Phase 2 Project and auto parts in Rayong (approximate capacity of 100,000 units per year) with a total investment value of 8,438.7 million baht
- 10. Honda Automobile (Thailand) Company Limited: car manufacturing under the Ecocar Phase 2 Project in Prachinburi (approximate capacity of 100,000 units per year) with a total investment value of 8,161 million baht
- 11. Next Can Innovation Company Limited: metal cans manufacturing in Saraburi (approximate capacity of 600 million units per year) with a total investment value of 1,400 million baht
- 12. Mr. Faith Kemal Ebiclioglu: refrigerator manufacturing in Rayong (approximate capacity of 573,300 units per year) with a total investment value of 3,142.3 million baht
- 13. PTT Global Chemical Public Company Limited: ethylene production in Rayong (production capacity of 175,000 tons per year) with a total investment value of 9,825.3 million baht

- 14. Nissan Motor Asia Pacific Company Limited: research and development (R&D) project for vehicles and parts to support Nissan worldwide services in Samut Prakan with a total investment value of 1,087 million baht
- 15. Earth-tech Environment Company Limited: electricity from natural waste (Refuse Derived Fuel) in Saraburi (production capacity of 9.4 megawatts) with a total investment value of 1,359 million baht
- 16. Ruampol Bio Power Company Limited: electricity and steam from bio mass in Nakhon Sawan (production capacity of 50 megawatts and steam production capacity of 250 tons per hour) with a total investment value of 1,000 million baht
- 17. Kaset Thai Bio Power Company Limited: electricity and steam from bio mass in Nakhon Sawan (production capacity of 60 megawatts and steam production capacity of 330 tons per hour) with a total investment value of 1,540 million baht
- 18. Hemaraj Land and Development Public Company Limited: industrial zone of 3,160.5 rai in Chonburi with a total investment value of 5,442.8 million baht
- 19. Hemaraj Eastern Seaboard Industrial Estate Company Limited: industrial zone of 2,202 Rai in Chonburi with a total investment value of 2,845 million baht
- 20. Rayong 2012 Company Limited: industrial zone of 1,232 Rai in Rayong with a total investment value of 1,569.7 million baht
- 21. Nok Airlines Public Company Limited: air transportation services for domestic and international flights with a total investment value of 2,317.6 million baht

There are 2 amendment projects with additional investment, which are

- 22. Toyotomi Auto Parts (Thailand) Company Limited: metal parts forming for motor vehicles in Chachoengsao with an additional 300 million baht in investment value and an increase in production capacity to 6,200,000 units
- 23. Nissan Motor (Thailand) Company Limited: car manufacturing under the Eco-car Phase 2 Project, with an additional 3,113 million baht in investment value and an increase in production capacity from 120,000 to 134,000 units per year
