**The BOI's board approves 17 investment projects worth 43 billion baht**

Mrs. Hirunya Suchinai, Secretary General of the Thailand Board of Investment (BOI), revealed after a BOI board meeting chaired by Prime Minister General Prayuth Chan-o-cha that the board had approved 17 projects, with a total investment value of 43,467.7 million baht, including:

1. NS BlueScope (Thailand) Company Limited: Aluminum alloy-coated steel sheet, pre-painted corrugated steel and iron sheet manufacturing in Rayong with a total investment value of 3,279.2 million baht.
2. SEI Thai Electric Conductor Company Limited: Aluminum alloys for electric wire and cable products manufacturing in Rayong with a total investment value of 1,324 million baht.
3. Aoyama Thai Company Limited: Fastener products manufacturing in Rayong with a total investment value of 2,193 million baht.
4. Thai Beverage Can Company Limited: Aluminum can manufacturing in Saraburi with a total investment value of 1,410 million baht.

Investment project 5 - 7. Daicel Safety Systems (Thailand) Company Limited: Automobile parts such as airbag inflator and gas generator manufacturing in Prachinburi with a total investment value of 2,494.2 million baht.

8. Otani Radial Company Limited: Tire manufacturing in Nakornpathom with a total investment value of 6,555.8 million baht.
9. Millimed Company Limited: Medicine manufacturing in Chiang Rai with a total investment value of 1,436.4 million baht.
10. SRF Industries (Thailand) Company Limited: Plastic film and metalised film manufacturing in Rayong with a total investment value of 2,429 million baht.
11. Mr. Somsak Dararattanaoj: Paper pulp for newspapers manufacturing in Mahasarakam with a total investment value of 5,500 million baht.
12. Siam Cellulose Company Limited: Paper pulp for corrugated paper manufacturing in Kanchanaburi with a total investment value of 1,408.2 million baht.
13. Singburi Sugar Company Limited: Electricity generation from biomass and stream in Singburi with a total investment value of 910 million baht.
14. U-Thong Green Power Company Limited: Electricity generation from biomass in Suphanburi with a total investment value of 1,665 million baht.
15. Energy Absolute Public Company Limited: Electricity generation from solar energy in Phitsanulok with a total investment value of 8,500 million baht.
16. Mr. Roger Rensch Reynolds: Aquarium investment in Phuket with a total investment value of 1,440 million baht.
17. Hemaraj Eastern Seaboard Industrial Estate 4 Company Limited: Industrial estate development in Rayong with a total investment value of 2,922.1 million baht.
