### **BOI Board Approves Over 100 Billion Baht of Investments**

**Boosts the use of agro raw material and electricity generation from renewable energy**

Mrs. Hirunya Suchinai, Secretary General of the Thailand Board of Investment (BOI), revealed after the BOI board meeting chaired by Prime Minister General Prayuth Chan-o-cha that the board had approved of 29 projects, a total investment value of 101,581 million baht.

#### **Agro and agro products sector – a total investment value of 32,145 million baht**

1. Betagro Agro Industry Company Limited: Expansion of eviscerated pork meat production in Prajinburi (production capacity of 46,430 tons per year) with a total investment value of 2,440 million baht.

Investment projects 2. – 4. Mr. Benjamin William Bootle: a total investment value of 18,200 million baht.

2. Raw milk (production capacity of 190,000 tons per year), organic fertilizer (production capacity of 17,500 tons per year), and biogas (production capacity of 24,940,000 cubic meters per year) production in Lopburi with a total investment value of 5,500 million baht.
3. Raw milk (production capacity of 190,000 tons per year), organic fertilizer (production capacity of 17,500 tons per year), and biogas (production capacity of 24,940,000 cubic meters per year) production in Chiang Mai with a total investment value of 5,500 million baht.
4. High quality products from raw milk production in Lopburi (production capacity of 380,000 tons per year) with a total investment value of 7,200 million baht. The products from raw milk are specifically for people with lactose intolerance.

5. Ajinomoto (Thailand) Company Limited: Expansion of food seasoning powder and cube production in Saraburi (production capacity of 40,000 tons per year) with a total investment value of 1,085 million baht.
6. B. Foods Products International Company Limited: Expansion of ready meal food from frozen meat production in Lopburi (production capacity of 24,000 tons per year) with a total investment value of 1,910 million baht.
7. CPF (Thailand) Public Company Limited: Expansion of processed food from frozen meat production in Chachoengsao (production capacity of 13,070 tons per year) with a total investment value of 2,510 million baht.

Investment projects 8. – 11. Energy Absolute Public Company Limited: Expansion of 4 projects in green diesel (total production capacity of 264,960 tons per year) and dehydrated palm kernel (total production capacity of 115,200 tons per year) production with a total investment value of 6,000 million baht (1,500 million baht per project). Expansion of 2 projects are in Chumphon and the other 2 projects are in Nakhon Si Thammarat.

**Metal products, machinery and transport equipment sector – a total investment value of 13,570 million baht**

12. Mr. Huashun Xie: Vehicle tire such as truck and bus radial tire (production capacity of 1,200,000 tires per year) and off the road tire (production capacity of 30,000 tires per year) production in Rayong with a total investment value of 13,570 million baht.

**Chemicals, paper and plastics sector – a total investment value of 8,488 million baht**

13. Bangkok Industrial Gas Company Limited: Expansion of oxygen and nitrogen (production capacity of 729,000 tons per year) and liquid oxygen, liquid nitrogen, and liquid argon (production capacity of 225,500 tons per year) production in Rayong with a total investment value of 1,968 million baht.
14. Mr. Pornarong Jira: Printing paper and craft paper production in Lopburi (production capacity of 200,000 tons per year) with a total investment value of 3,000 million baht.
15. Mr. Chan Seneenant: Printing paper production in Singburi (production capacity of 120,000 tons per year) with a total investment value of 1,320 million baht.
16. Environment Pulp and Paper Company Limited: Expansion of biodegradable food packaging production in Nakhon Sawan (production capacity of 18,870 tons per year) with a total investment value of 2,200 million baht.

**Services and public utilities sector – a total investment value of 47,378 million baht**

National Power Plant 12 Company Limited: Expansion of electricity from black liquor generation (production capacity of 135 megawatts) and steam generation (production capacity of 464 tons per hour) and white liquor (production capacity of 250 cubic meters per hour) production in Buriram with a total investment value of 9,160 million baht.
18. Siam Power Company Limited: Electricity from natural gas generation (production capacity of 117 megawatts) and steam generation (20 tons per hour) in Rayong with a total investment value of 4,650 million baht.

19. Berkprai Cogeneration Company Limited: Electricity from natural gas generation (production capacity of 100 megawatts) and steam generation (10 tons per hour) in Ratchaburi with a total investment value of 5,323.6 million baht.
20. Gulf NRV 1 Company Limited: Electricity from natural gas generation (production capacity of 133 megawatts) and steam generation (30 tons per hour) and water for industrial use (production capacity of 2,800 cubic meters per hour) production in Nakhon Ratchasima with a total investment value of 5,745 million baht.

Gulf NRV 2 Company Limited: Electricity from natural gas generation (production capacity of 133 megawatts) and steam generation (30 tons per hour) and water for industrial use (production capacity of 2,800 cubic meters per hour) production in Nakhon Ratchasima with a total investment value of 5,745 million baht.

24. Mitr Phol Bio-Power (Kuchinarai) Company Limited: Electricity from biomass fuel generation (bagasse and wood chips) (production capacity of 45 megawatts) and steam generation (270 tons per hour) in Kalasin with a total investment value of 1,780 million baht.
25. Tung Bua Power Company Limited: Electricity from refuse derived fuel generation (production capacity of 9.9 megawatts) in Nakhon Pathom with a total investment value of 1,250 million baht.
26. Din Suay Nam Sai Company Limited: Steam generation (production capacity of 60 tons per hour) and water for industrial use (production capacity 60,000 cubic meters per year) production in Chai Nat with a total investment value of 1,200 million baht.
27. Precious Neptune Company Limited: Transportation of bulk cargo such as agro products, steel, fertilizer, coal, and ore via ship in the areas such as the United States of America, Europe, Africa, the Middle East, India, and countries in South East Asia with a total investment value of 918 million baht.
28.
