Large Projects to Invest Over 200 Billion Baht

PTT's gas transmission pipeline - industrial estate expand more than 7,000 rai

Mrs. Hirunya Suchinai, Secretary General of the Thailand Board of Investment (BOI), revealed after the BOI board meeting chaired by Prime Minister General Prayuth Chan-o-cha that the board had approved of 34 projects, a total investment value of 266,387.7 million baht.

Activities in agriculture and agricultural products sector, including:

1. Betagro Agro Industry Company Limited: Expansion of chicken eggs production in Lopburi and Pathum Thani (production capacity of 386,530,000 eggs per year) with a total investment value of 1,565 million baht.

Investment projects 2. – 6. Betagro Agro Industry Company Limited: Expansion of 5 projects in swine production in Ang Thong, Saraburi, Lopburi, Chai Nat, and Nakhon Ratchasima (total production capacity of 660,000 pigs per year) with a total investment value of 5,734.7 million baht.

7. Thai SPF Products Company Limited: Expansion of swine production in Rayong, Prajinburi, and Sa Kaeo (total production capacity of 180,000 pigs per year) with a total investment value of 1,458.3 million baht.

Investment projects 8. – 10. Betagro Public Company Limited: Expansion of animal feeds production in Petchburi, Sa Kaeo, Nakhon Ratchasima (total production capacity of 1,776,000 tons per year) with a total investment value of 6,459.8 million baht.

- 11. Betagro Safety Meat Packing Company Limited: Expansion of pork meat carvings production in Lopburi (production capacity of 124,290 tons per year) with a total investment value of 2,269.4 million baht.
- 12.B. Foods Products International Company Limited: Expansion of eviscerated chicken meat production in Lopburi (production capacity of 47,730 tons per year) with a total investment value of 1,735.2 million baht.
- 13. Global Green Chemicals Public Company Limited: Expansion of refined, bleached, and deodorized palm oil and Bio-Diesel production in Chonburi (production capacity of 297,370 tons per year) with a total investment value of 1,600 million baht.
- 14. Ajinomoto Sales (Thailand) Company Limited: Expansion of coffee products production in Saraburi (production capacity of instant coffee in sealed container: 119,320 tons per year, production capacity of instant coffee: 4,380 tons per year, production capacity of concentrated coffee: 350 tons) with a total investment value of 2,786.8 million baht.
- 15. Ubon Bio Ethanol Company Limited: Expansion of 99.5% ethanol production in Ubon Ratchathani (production capacity of 297,000,000 liters per year) with a total investment value of 6,869.4 million baht.

Activities in mineral, ceramics, and basic metals sector, including:

- 16. Mr. Manop Sirikul: Steel production in Rayong (production capacity of 500,000 tons per year) with a total investment value of 7,500 million baht.
- 17. Mr. Pornchai Tonitiwong: Aluminum-zinc coated steel sheets and color coated steel sheets production in Chachoengsao (production capacity of 122,000 tons per year) with a total investment value of 2,600 million baht.

Activities in light Industry, including:

18. Mitsui Hygiene Materials (Thailand) Company Limited: Expansion of nonwoven fabric production in Rayong (production capacity of 16,000 tons per year) with a total investment value of 1,726.9 million baht.

Activities in metal products, machinery, and transport equipment sector, including:

19. Nissan Motors (Thailand) Company Limited: Expansion of pick up passenger vehicle (PPV) manufacturing in Samut Prakarn (production capacity of 62,000 units per year) with a total investment value of 6,566.1 million baht.

Activities in chemicals, paper, and plastics sector, including:

- 20.BST Specialty Company Limited: Synthetic latex production in Rayong (production capacity of 4,000 tons per year) with a total investment value of 958 million baht.
- 21. Expalkan (Thailand) Company Limited: Polylactic acid (PLA) (production capacity of 90,000 tons per year), amorphous lactide (production capacity of 75,000 tons per year), and lactic acid (technical grade) (production capacity of

- 5,000 tons per year) production in Rayong with a total investment value of 4,000 million baht.
- 22. PTT Global Chemical Public Company Limited: Expansion of ethylene (production capacity of 521,430 tons per year), propylene (production capacity of 272,140 tons per year), and butadiene (production capacity of 114,140 tons per year) production in Rayong with a total investment value of 33,946.2 million baht.
- 23.Mrs. Sujaree Rungrojsoontorn: Styrene monomer production in Rayong (production capacity of 60,000 tons per year) with a total investment value of 2,306 million baht.
- 24.Mrs. Sujaree Rungrojsoontorn: Ethylene, product of upstream petrochemical which can be used for plastic resins production, production in Rayong (production capacity of 300,000 tons per year) with a total investment value of 16,330.6 million baht.
- 25.PTT Phenol Company Limited: Expansion of cyclohexanone, a substrate of caprolactam production which can be used for plastics resins in nylon 6 or synthetic nylon fibers, production in Rayong (production capacity of 164,250 tons per year) with a total investment value of 3,353.3 million baht.
- 26. PTT Phenol Company Limited: Expansion of polycarbonate, translucent, hard, and sticky plastic that is mostly used in the automotive and electronics and electrical appliances industries, production in Rayong (production capacity of 142,350 tons per year) with a total investment value of 18,473 million baht.
- 27.PTT Phenol Company Limited: Expansion of isopropyl alcohol, an important chemical for the pharmaceutical and ink and paint industry, production in Rayong with a total investment value of 1,628.5 million baht.
- 28. Siam Kraft Company Limited: Expansion of paper industry production in Kanchanaburi (production capacity of 100,000 tons per year) with a total investment value of 1,733 million baht.

Activities in services and public utilities sector, including:

- 29. Kerry Siam Seaport Company Limited: Expansion of products transfer for cargo ships service (service for containers account for around 540,000 TEU per year and general service account for 5,100,000 tons) in Chonburi with a total investment value of 4,096.9 million baht.
- 30.PTT Global Chemical Public Company Limited: Electricity and steam generation from natural gas in Rayong (production capacity of 76 megawatts and steam generation capacity of 280 tons per hour) with a total investment value of 3,501 million baht.
- 31. PTT Public Company Limited: Expansion of natural gas transportation pipeline with the total distance of 430 kilometers from Rayong to Nonthaburi with a total investment value of 96,500 million baht.
- 32.Mr. Kiatisuk Lertsiriamorn: Logistics industrial estate covering 3,000 rai in Chonburi with a total investment value of 22,344.3 million baht.
- 33. Rojana Industrial Park Public Company Limited: Expansion of industrial estate covering 1,000 rai in Chonburi with a total investment value of 4,015 million baht.
