

- 100% foreign ownership
- No local content requirements
- No export requirement
- No restriction on foreign currency

- Exemption of import duties on machinery
- Exemption of import duties on raw or essential material imported for export
- Exemption of import duties on goods import for R&D
- Corporate income tax (CIT) exemption
- 50% CIT reduction







BOI's Investment Incentives for Water Management Related Activities

Activities	Conditions	Incentives
7.1.5 Production of tap water, industrial water or steam from waste	Project must receive a permit for factory license no. 101 i.e. central waste treatment.	A2 8 years CIT exemption
7.1.6 Production of tap water, industrial water or steam		A3 5 years CIT exemption
7.1.12 Waste treatment or disposal	In case of project use landfill method, only hazardous waste treatment shall be promoted and project must receive approval of environmental impact assessment from the Office of Natural Resources and Environmental Policy and Planning (ONEP) before applying submitted investment promotion application.	A2 8 years CIT exemption

CIT Exemption:
8 years

7.1.5 Production of tap water, industrial water or steam from waste

Condition

Project must receive a permit for factory license no. 101
i.e. central waste treatment.

CRITERIA

1. Wastewater must undergo continuous treatment until it reaches the water production phase to become suitable for use as tap water, industrial water, or steam.
2. A project must have wastewater treatment system and utilize modern technology in the production of water.
3. The water derived from the production process must exceed the quality standards set by Provincial Waterworks Authority.

The project generates revenue through the sale of tap water, industrial water, and steam.



Remark:

- A permit for factory license no. 101 is issued by Department of Industrial Works.
- Equivalent permit i.e. Factory Operation Permit in industrial estate etc.

CIT Exemption:
5 years

7.1.6 Production of tap water, industrial water or steam

CRITERIA

1. A project must utilize modern technology in the production of water.
2. The water derived from the production process must exceed the quality standard set by Provincial Waterworks Authority.
 - Tap water is water that contains various mineral solutions, making it suitable for consumption in appropriate quantities.
 - Industrial water is water that has been treated to eliminate specific minerals or substances, such as demineralized water, or it can also undergo a phase change process, such as becoming chilled water or steam.

CIT Exemption:
8 years

7.1.1.2 Waste treatment or disposal

CONDITION

Regarding waste disposal through the landfill method, BOI will give investment promotion only for landfilling hazardous waste and get approval of the environmental report from relevant agencies before applying for promotion.

CRITERIA

1. Treatment system must utilize modern technology.
2. The water derived from the treatment process must meet the legal quality standards i.e. wastewater standard of Ministry of Industry or industrial estates etc.

The project generates revenue through wastewater treatment service fees


