Announcement of the Board of Investment

Amendments to Activity 4.2.4 for Manufacture of Circuit Board and/or Parts

Subsequent to the Announcement of the Board of Investment No. 9/2565, dated December 8, 2022, regarding Measures to Promote Investment in Industries That are Important to the Country's Development;

To promote investment in the manufacture of printed circuit board (PCB) industry, encompassing PCB manufacturers, producers of raw and essential materials used in the production process, and service providers who are a critical part of the supply chain, including both Thai and foreign operators, aiming to establish and develop a PCB industry cluster in Thailand; By virtue of Section 16 of the Investment Promotion Act B.E 2520 (1977), the Board of Investment issues the following announcement to amend the eligible activity for promotion by repealing the terms in the activity 4.2.4 on the list appended to the Announcement of the Board of Investment No. 9/2565 dated December 8, 2022, and replacing them with the following terms:
